Course programmes are made public in ÕIS no later than during the preliminary week of the semester.

A course programme is a document that defines the content and achievement requirements of a subject where the responsible lecturer also establishes the requirements for participation, independent work, taking and passing assessments, principles and criteria of assessment; outlines the times, topics and participation requirements for seminar work; lists compulsory and replacement literature; describes the content of the course and presents other information necessary for participation, and for completion of the course.

In ÕIS, the course materials are attached to the course programme by the lecturer.

Moodle is TU official e-learning environment. A lecturer can upload course materials to Moodle in addition to or instead of ÕIS. In that case the lecturer adds a link to Moodle course to make it easily accessible.
