1	It is not clear from the submitted documents or the interview that the candidate's previous education and/or work experience are related to the field of study, financial security is lacking, and knowledge of the country/university is lacking. The candidate has not planned his/her living and study arrangements in the destination country.	On the basis of the submitted documents or the interview, there is no clear interest in the studied specialty or it is general. During the interview, the candidate does not explain understandable reasons why he/she wants to study. The submitted motivation letter is unclear and not related to the study programme. The candidate's knowledge of the curriculum or study regulations at TLU is incomplete.	The master's thesis plan submitted and the interview do not reveal the candidate's previous experience with empirical research, the knowledge in the field of the master's thesis is incomplete. The plan is presented in general terms, incompletely formalized and is not implementable.
2	From the submitted documents or based on the interview, the relation of the candidate's previous education and/or work experience with the field of study is weak, the candidate's financial security is unclear or he cannot justify/explain it clearly, the knowledge of the country/university is at an elementary level, coping in the destination country has been planned generally.	Based on the submitted documents or the interview, the interest in the study specialty is weak or it is general. The candidate gives generalized reasons for reasons to study. The submitted motivation letter has little to do with the study area. The candidate's knowledge of the study programme or study regulations at TLU is superficial.	The master's thesis plan submitted and the interview reveal the candidate's lack of previous experience to empirical research, the knowledge in the field of the master's thesis is very general. The plan is presented in general terms, formalized with shortcomings, and its implementability is questionable.

Based on the master's thesis plan submitted and the interview, the candidate has previous experience to empirical research, knowledge of the field of the master's thesis is average. The plan is presented in a generalized way, is correctly formalized, it can be implemented with some improvements. During the interview, the candidate partially explains the choice of methodology of his/her master plan. Its implementation perspective is possible with some improvements, and candidate describes in

			average level the methodological details of the plan.

There is a plan for financial security for the period of studies, the knowledge of the country/university is good. Getting by in the destination country is well planned.	Based on the submitted documents or the interview, the area to be studied is one of the candidate's first choices. The candidate has good knowledge of the study programme, subjects and study regulations at TLU. The candidate has a vision of the perspectives of his/her education for future work, but he/she relates his/her goals to social processes generally.	On the basis of the master's thesis plan submitted and the interview, the candidate has sufficient previous experience to empirical research, the knowledge of the field of the master's thesis is good. The plan is clearly presented, correctly formatted, and can be implemented with a few improvements. During the interview, the candidate explains the perspective in general terms and logically discusses the methodological details of the plan.

The candidate has detailed knowledge of the study programme, subjects and study regulations at TLU. The candidate has a clear vision of the perspectives of his education for future work and relates his goals to social processes with detailed understanding.	Based on the master's thesis plan submitted and the interview, the candidate is an experienced with empirical research, the knowledge of the field of the master's thesis is excellent. The plan is presented clearly, has clear schedule, is, correctly formatted, is implementable. During the interview, the candidate explains in detail the relevance of his Master's project to the study area, the perspective and it's need in society, and the methodological rationale.
